

**CITY COUNCIL MEETING
OZARK, ALABAMA
MONDAY, DECEMBER 5, 2022**

The City Council of the City of Ozark, Alabama, met in Regular Session in the Council Chamber of the Municipal Complex at 5:30 P.M. on Monday, December 5, 2022. Upon roll call the following members were present:

Also present: Denise Strickland, who acted as clerk of the meeting, Chief Philip Prince, Chief Charles Ward, Deputy Chief Michael Bryan, Bret Head, Ryan Campbell, Joseph McNabb, Ozzie Maianeto, Justin Byrd and Joe Adams.

Council President Pro Tem Jackson gave the prayer followed by Mayor Blankenship leading everyone in the Pledge of Allegiance.

The Council having read the minutes from the Regular Council Meeting held on November 14, 2022 President Pro Tem Jackson asked the wishes of the Council. Councilmember Perault made a motion to approve the minutes of the Regular Council Meeting held on November 14, 2022, which motion was seconded by Councilmember Harlow. The Council voted unanimously in favor thereof.

Council President Pro Tem Jackson advised the Council that it was time to set the Agenda. Councilmember Harlow made a motion to set the Agenda as presented, which motion was seconded by Councilmember Enfinger. The Council voted unanimously in favor thereof.

Councilmember Enfinger mad a motion to approve the revision of the Lease Purchase Agreement with George Gonzalez d/b/a USA Property Pros from two (2) years to three (3) years, which motion was seconded by Councilmember Perault. The Council voted unanimously in favor thereof.

Councilmember Harlow introduced a Resolution Declaring Surplus Real Property, Tax Parcel 26-06-04-20-4-000-009.000 (Old Ozark Building Supply) and moved for its adoption, which motion was seconded by Councilmember Enfinger. The Council voted unanimously in favor thereof.

Councilmember Perault introduced a Group Resolution Confirming the Cost of a Weed Lein at: 333 Roy Avenue in the amount of \$275; 165 Roy Avenue in the amount of \$375; 336 Roy Avenue in the amount of \$300; Broad Street Lot in the amount of \$250; 191 Liberty Avenue in the amount of \$350; 615 Bermuda Street in the amount of \$350 and 760 North Union Avenue in the amount of \$400 and moved for its adoption, which motion was seconded by Councilmember Enfinger. The Council voted unanimously in favor thereof.

Councilmember Enfinger made a motion to approve a change to the Capital Outlay Funding for the FY 2022/2023 Budget for the New Ladder Truck from \$929,500 to \$997,565, which motion was seconded by Councilmember Harlow. The Council voted unanimously in favor thereof.

Council President Pro Tem Jackson advised the Council that a Court Report and Financial Report were in their packets for review.

With there being no further business to come before this Regular Council Meeting of December 5, 2022, Councilmember Enfinger made a motion to adjourn, which motion was seconded by Councilmember Perault. The Council voted unanimously in favor thereof.
