Councilmember Perault gave the prayer followed by Council President Simechak leading everyone in the Pledge of Allegiance.

The Council having read the minutes from the Regular Council Meeting held on **July 15**, **2025** President Simechak asked the wishes of the Council. Councilmember Jackson made a motion to approve the minutes of the Regular Council Meeting held on **July 15**, **2025** which motion was seconded by Councilmember Harlow. The Council voted unanimously in favor thereof.

Council President Simechak advised the Council that it was time to set the Agenda. Councilmember Perault made a motion to set the Agenda as presented, which motion was seconded by Councilmember Harlow. The Council voted unanimously in favor thereof.

Councilmember Enfinger introduced a Resolution Declaring Certain Properties a Public Nuisance at 430 Magnolia St, 566 Newton Ave, 616 Magnolia St, 198 Magnolia St, 615 N. Merrick Ave, 545 Eufaula St, 551 Newton Ave and moved for its adoption, which motion was seconded by Councilmember Perault. The Council voted unanimously in favor thereof.

Councilmember Jackson introduced a Resolution Appointing Election Officials for the Municipal Election to be held on August 26, 2025 and moved for its adoption, which motion was seconded by Councilmember Harlow. The Council voted unanimously in favor thereof.

Councilmember Harlow made a motion to accept the bid for Street Paving project to Wiregrass Construction Co and Authorize the Mayor to execute agreement of such award in the amount of \$618,115.35 which motion was seconded by Councilmember Enfinger. The Council voted unanimously in favor thereof.

Councilmember Perault made a motion to approve a Growing Alabama Funding Agreement and Authorize the Mayor to execute agreement with Alabama Department of Commerce in the amount of \$150,000.00 with additional fund \$38,925.00 to be paid out of Reserve Funds for an Airport Project which motion was seconded by Councilmember Enfinger. The Council voted unanimously in favor thereof.

Councilmember Enfinger made a motion to approve the Mayor to execute an updated Use Agreement for Batting Cage at Eagle Stadium with the Ozark City Schools which motion was seconded by Councilmember Jackson. The Council voted unanimously in favor thereof.

Councilmember Harlow introduced a Resolution to Adopt a Transportation Plan for FY 2026 and moved for its adoption, which motion was seconded by Councilmember Perault. The Council voted unanimously in favor thereof.

Councilmember Jackson introduced a Resolution Confirming the Cost of a Weed Lien at 227 Bermuda St. in the amount of \$450.00 and moved for its adoption, which motion was seconded by Councilmember Enfinger. The Council voted unanimously in favor thereof.

Councilmember Jackson introduced a Resolution Confirming the Cost of a Weed Lien at Church St. (Parcel no. 26 06 08 3 1 006 001.000) in the amount of \$525.00 and moved for its adoption, which motion was seconded by Councilmember Enfinger. The Council voted unanimously in favor thereof.

Councilmember Enfinger made a motion to set a Public Hearing for August 19, 2025 at 5:00PM for Declaring Certain Properties a Public Nuisance, which motion was seconded by Councilmember Harlow. The Council voted unanimously in favor thereof.

With there being no further business to come before this Regular Council Meeting of **August 5, 2025** Councilmember Jackson made a motion to adjourn, which motion was seconded by Councilmember Perault. The Council voted unanimously in favor thereof.
