The City Council of the City of Ozark, Alabama, met in Regular Session in the Council Chamber of the Municipal Complex at 5:30 P.M. on Tuesday **May 19, 2026**. Upon roll call the following members were present:

Councilmember Perault gave the prayer followed by Mayor Ward leading everyone in the Pledge of Allegiance.

The Council having read the minutes from the Regular Council Meeting held on **May 5, 2026** President Jackson asked the wishes of the Council. Councilmember Cummings made a motion to approve the minutes of the Regular Council Meeting held on **May 5, 2026** which motion was seconded by Councilmember Perault. The Council voted unanimously in favor thereof.

Council President Jackson advised the Council that it was time to set the Agenda. Councilmember Macario made a motion to set the Agenda as presented, which motion was seconded by Councilmember Cummings. The Council voted unanimously in favor thereof.

Councilmember Macario made a motion to approve the First and Second Reading Application 050 – Retail Beer (Off Premises Only); 070 – Retail Table Wine (Off Premises Only) and 990 – Tobacco and Alternative Nicotine Products: Applicant: Tri Star Energy LLC; Trade Name: Twice Daily White Bison 3148, 1090 S. US Highway 231, Ozark, AL 36360. General Counsel Secretary: Leslie Cherry, 5333 McGavock Rd, Brentwood, TN 37027 and CEO: Steven Hostetter, 107 Woodside Dr, Dickson, TN 37055., which motion was seconded by Councilmember Cummings. The Council voted unanimously in favor thereof.

Councilmember Perault introduced a resolution for an ALDOT FY 2027 Transportation Alternatives Set-Aside Program for sidewalk construction and moved for its adoption which motion was seconded by Councilmember Macario. The Council voted unanimously in favor thereof.
