

**CITY COUNCIL MEETING
OZARK, ALABAMA
TUESDAY, MARCH 3, 2020**

The City Council of the City of Ozark, Alabama, met in Regular Session in the Council Chamber of the Municipal Complex at 5:30 P.M. on Tuesday, March 3, 2020. Upon roll call the following members were present:

Councilmember Perault gave the prayer followed by Mayor Bunting leading everyone in the Pledge of Allegiance.

The Council having read the minutes from the Regular Council Meeting held on February 18, 2020 at 5:30 P.M. President Pro Tem Enfinger asked the wishes of the Council. Councilmember Simechak made a motion to approve the minutes of the Regular Council Meeting held on February 18, 2020, which motion was seconded by Councilmember Jackson. The Council voted unanimously in favor thereof.

President Pro Tem Enfinger advised the Council it was time to set the Agenda and if there were any changes to be made. Councilmember Perault made a motion to set the Agenda as presented, which motion was seconded by Councilmember Simechak. The Council voted unanimously in favor thereof.

Councilmember Jackson introduced a Resolution supporting a NRPA Grant for the Autrey Center and moved for its adoption, which motion was seconded by Councilmember Perault. The Council voted unanimously in favor thereof.

Councilmember Simechak made a motion to appoint Councilmember Jackson as the Voting Delegate for the Annual Convention of the Alabama League of Municipalities to be held on May 16-19, 2020 in Tuscaloosa with Councilmember Perault as 1st Alternate and Councilmember Simechak as 2nd Alternate, which motion was seconded by Councilmember Perault. Councilmember Jackson abstained from the vote. The motion passed.

Councilmember Perault made a motion to approve a Budget Amendment, which motion was seconded by Councilmember Jackson. The Council voted unanimously in favor thereof.

Councilmember Jackson made a motion to approve the expansion of the Entertainment District to include the Ann Rudd Art Center, which motion was seconded by Councilmember Simechak. The Council voted unanimously in favor thereof.

Councilmember Simechak made a motion to approve the request to enact the Entertainment District for the 2020 Ozark Lights Up events, which motion was seconded by Councilmember Perault. The Council voted unanimously in favor thereof.

Council President Pro Tem Enfinger advised the Council that there was a Financial Report in their packets for review.

With there being no further business to come before this Regular Council Meeting of March 3, 2020, Councilmember Jackson made a motion to adjourn, which motion was seconded by Councilmember Simechak. The Council voted unanimously in favor thereof.
