The City of Ozark invites bids for the exclusive responsibility for alcoholic beverage services at contracted events at the Ozark Civic Center, for the period of January 16, 2026, through September 30, 2026.

SCOPE OF WORK:

The successful bidder will be responsible for the sale and distribution of alcoholic beverages during certain events hosted at the Ozark Civic Center. All sales must comply with local, state, and federal regulations regarding the sale of alcohol. The successful bidder will provide their staff, equipment, and all supplies necessary for the sale of alcohol.

BID REQUIREMENTS:

Interested bidders must submit the following:

- A completed bid proposal form
- A detailed plan outlining the types of beverages to be sold
- Additional services proposed (e.g., bartending, concessions, setup, etc.)
- Proof of a valid liquor license and insurance, (can be obtained after the ABC Board awards it)

Please note that the bid award winner will still need City Council and ABC Board approval for the location.

Sealed bids will be received by the City of Ozark at the City Municipal Complex in Ozark, Alabama, until **10 AM on Monday, June 1, 2026**, and at that time publicly opened for the Alcohol Beverage Services for Contracted Events at the Ozark Civic Center. The bid opening will be held on the 2nd floor of the Ozark Municipal Complex in Room 240. Alternatively, bids may be mailed to the Ozark City Clerk's Office, P.O. Box 1987, Ozark, AL 36361.
