Councilmember Jackson gave the prayer followed by Council President Simechak leading everyone in the Pledge of Allegiance.

The Council having read the minutes from the Regular Council Meeting held on **September 16, 2025** President Simechak asked the wishes of the Council. Councilmember Perault made a motion to approve the minutes of the Regular Council Meeting held on **September 16, 2025**, which motion was seconded by Councilmember Jackson. The Council voted unanimously in favor thereof.

Council President Simechak advised the Council that it was time to set the Agenda. Councilmember Harlow made a motion to set the Agenda as presented, which motion was seconded by Councilmember Enfinger. The Council voted unanimously in favor thereof.
